### New Courses and Course Report

The Training Department and Training Room have experienced a busy year. Along with our regular courses of Councillor Training Days, Chairman's Day training, New Clerks training we have also had new courses in the Calendar this year, some that have actually been put forward and suggested by Councillors and Clerks, Financial Regulations, Social Media, DIY Public Relations & Exclusive Rights of Burial Cemetery Course, some of which we had to run twice owing to the demand. Along with our certificated courses for Fire Safety, Health & Safety & First Aid we have run over 50 courses this year.

Looking at the year ahead we expect to receive a high volume of new Councillors to be trained owing to the elections and also new Chairmen to seeking training. Planning for the year ahead we are introducing new courses; Basic Playground Inspection Course, Cemetery Customer Care Course and Risk Assessment.

The EALC staff take great pride in delivery services and support to Member Councils. We understand how hard Councillors work often giving their time freely and the burden that falls on Clerk to ensure that the Council is working within the law.
